Norma, a 1947 graduate of the Division of University Extension (graduates of the Division became Woodsworth alumni with the creation of the College in 1974), believed in the power of education. Her will included a bequest for Woodsworth College that established the Norma Brock Award which benefits students who are single parents as well as mature and part-time students.

Since its inception six years ago, the award has provided \$20,000 per year. A total of \$120,000 in scholarship funding has been awarded to 64 recipients. The awards ranged between \$1,000 and \$3,000 each.

RECENTLY, the University of Toronto signed a Strategic Mandate Agreement (SMA) with the Province of Ontario. SMA2 recognizes the

University of Toronto as an international leader in research and teaching. Going forward a number of performance indicators will be used to benchmark the success of the institution. An example of just two of these indicators are central to the Woodsworth College mission: access programs (e.g. our Millie Rotman Shime Academic Bridging Program) and opportunities for students to have an international experience (our Summer Study Abroad Program). Supporting an ever increasing number of students who wish to participate in these opportunities, many with financial need, is a fundraising priority for us.

Woodsworth College has been fortunate to have received many bequests over the years, all of which have directly benefitted our students through the establishment of bursaries and merit-based awards. We are also very grateful to the donors who have informed us of their planned gift intentions. These donors know that their future gift will support students, and not only that, donors are able to give us direction as to where they would like to see their gift having the greatest impact. For example, some donors are interested in helping students studying part-time, while others would like to further support students in the Woodsworth One Program or the Summer Study Abroad Program.

Through the generosity of Woodsworth donors, many of our students have been able to continue on their educational journeys – especially when financial pressures sometimes get in the way.

As a way of celebrating our bequest donors, we created the Woodsworth College Legacy Society, which meets once a year for a luncheon at the College. DID YOU KNOW? TAX-SMART GIVING

Donating publicly traded stocks and securities is a tax-smart way to support Woodsworth College and U of T. You will receive a charitable tax receipt for the fair market value of the donated security and you will not pay tax on any capital gain.

You can designate your gift to a Woodsworth priority that meets your interests.

Eligible gifts of stocks and securities include shares, debt obligations or rights listed on a designated stock exchange, a share of the capital stock of a mutual fund corporation, a unit of a mutual fund trust, an interest in a related segregated fund trust, or a prescribed debt obligation.

BENEFITS OF GIFTS OF STOCKS AND SECURITIES:

- The capital gain inclusion rate is zero when eligible stock or securities are donated directly to U of T.
 If you sell the shares and donate the proceeds, you will be required to pay capital gains tax.
- The value of your charitable tax receipt will be based on the market closing price on the day that U of T receives your stock or securities in its brokerage account.
- Donors making a gift of shares acquired through an employee stock option plan of a publicly traded company benefit from the favourable treatment of a zero capital gain inclusion rate. To be eligible for this benefit, you must donate these shares in the same calendar year and within 30 days of their acquisition.

CELEBRATING FALL CONVOCATION

ON THURSDAY, NOVEMBER 9TH,

Woodsworth College shared the annual fall convocation ceremony with Victoria College and the Ontario Institute for Studies in Education at Convocation Hall. The ceremony was presided over by President Meric Gertler and Chancellor Michael Wilson, with Dr. Wendy Cecil, former Chancellor of Victoria University, delivering the convocation address, which included some timely advice for the graduates as they prepare for careers and further studies. Former Woodsworth Alumni Association president Elizabeth Trotter acted as Esquire and Adam Doyle from the Professional and International Programs office carried the gonfalon.

At every convocation, there are many remarkable stories of the journeys that students take to the successful completion of their degrees. One such story from our fall convocation stands out. Danae-Linda Diamantopoulou-Hudson tells of her perseverance and the help she received from Woodsworth along the way:

"I should have graduated from high school in 1986 but instead I was rehabilitating from a spinal injury. I was, however, able to gain admittance to post-secondary education by attending the Pre-University Program (now Academic Bridging Program) at Woodsworth in 1988. My injury precluded me from completing degree studies at the time, but after many years away from academia, raising four sons, running a business and working two-part time jobs, there was nothing I wanted more, nowhere I would rather be, than back at the prestigious U of T as this continued to be a lifelong dream.

Skeptical that I would be able to finish my degree, as I had no idea how I would be able to manage balancing a family of six while working part time and studying, I enrolled anyway and decided I would just take it one semester at a time. I found that I loved every minute of being a student and was thriving in academia. However, with every crisis I faced I often thought, 'this is it, now I have to drop out.' Through it all, Woodsworth stood by my side providing financial support through bursaries and grants. One particularly supportive person at Woodsworth kept giving moral support and encouraging me to keep striving toward my goal. Without all of this support, I would not be where I am today, the proud recipient of an Honours Bachelor of Arts Degree with distinction, from UofT. My classmates think it took me five years, but my family knows it took me 30. What I know, is it was the best five years of my life! I am now on to the next challenge: two more years completing a Master's Degree in Teaching. This will be a second degree from U of T to hang proudly on my wall. Both degrees will arm me with knowledge and skills that will send me out into the world ready to face new challenges."

Professor Emeritus of Economics (UBC), Craig Riddell, delivered the third **Annual Morley Gunderson Lecture** in Labour Economics entitled *What Do Unions Do to Wage Inequality: The Roles of Gender, Skill and Public Sector Employment.* This event is co-presented by the Centre for Industrial Relations & Human Resources, the Department of Economics, and Woodsworth College.

The lecture was preceded by the presentation of the Gunderson Prize which recognizes CIRHR graduates who combine outstanding professional achievement with significant service to the Centre. This year's recipients were Clara Addo-Bekoe, Organizational Development and Learning Advisor at TVO, and Michael Villeneuve, Director, Centre for Employee Relations at Ontario Public Service. In conjunction with the Faculty of Arts & Science, the College was proud to present Woodsworth alumna Rita Leistner (WDW '88) for a presentation entitled **From the Battlefield to the Cut Block.** Rita is an internationally celebrated artist and documentary photographer whose presentation covered her journey from photographing conflict zones in Afghanistan and Iraq, to photographing and filming tree planters in western Canada.

Alumni were also invited to a special private tour by the artist of her exhibit, "The Tree Planters" at the Stephen Bulger Gallery in Toronto.

Professor Audrey Macklin, director of the Centre for Criminology and Sociolegal Studies, delivered the **2017 Saul Goldstein Memorial Lecture.** The lecture, presented in October, was



entitled: *Making and Remaking Canadians through Private Refugee Sponsorship.* Prof. Macklin's lecture outlined her current research project on private sponsor groups and how they and the refugees that they sponsor are affected by this process. Macklin, is one of five scholars in Canada to receive a 2017 Pierre Elliott Trudeau Fellowship, in recognition of her outstanding scholarship and pro bono work advocating for immigrant and refugee rights.
